- Craft your application with genuine enthusiasm and commitment to the community benefits of your project.
- Avoid generic responses; be creative and insightful.

5

#### **Demonstrate Value and Sustainability**

- Highlight how your project offers value for money and meets long-term community needs.
- Be realistic with your funding request and show prudent use of funds.

6

#### **Gather Support**

- Obtain letters of support from other community groups that will benefit from your project.
- Demonstrate that your proposal is well-considered and has broad backing.

7

#### **Ensure Compliance**

- Adhere strictly to the grant's submission guidelines and deadlines.
- Include all required documentation to avoid disqualification.

Following these steps will improve your organisation's chances of securing funding for an outdoor facility upgrade. Grants can transform your vision into reality without financial constraints.

# **COMMUNITY BUILDING PARTNERSHIP**

### **Eligibility Criteria:**

- To be considered eligible, the project must be submitted through the online system SmartyGrants.
- NSW association or non-distributing co-operatives registered with NSW Fair Trading
- Local Aboriginal Land Councils or Indigenous corporations registered with the Office of the Registrar of Indigenous Corporations
- NSW local councils and their Section 355 committees operating under the Local Government Act 1993. Local councils or their Section 355 committees are required to provide matched funding to the CBP grant amount awarded.
- Not-for-profit entities incorporated under an Act of Parliament
- Trusts that are registered with the Australian Charities and Not-for-profits Commission
- Public companies limited by guarantee.
- Applicants that received a grant through the CBP 2021 and CBP 2022 rounds must have acquitted their CBP 2021 and CBP 2022 projects by 21 February 2025, unless they have an active and approved extension in place to complete the project.
- Organisations listed on the ACNC Register must have a current and up-to-date record. Any organisation that has not met ongoing obligations to the ACNC will have funding withheld if the project is successful. Any outstanding issues must be resolved by the date Funding Agreements are due, or the grant offer may be withdrawn.
- An organisation eligible to apply for funding must apply under its own legal name and ABN.

# **MULTICULTURAL COMMUNITY FACILITIES GRANT**

You must own and manage multicultural community facilities in the Northern Territory (NT).



Have no overdue final reports or outstanding financial acquittals from previous NT Government-funded grants by the closing date of each application round



Comply with requirements under the relevant governing legislation, such as the Associations Act 2003 (NT), the Corporations Act 2001 (Cth), the Australian Charities and Not-for-profits Commission (ACNC), or the Office of the Registrar of Indigenous Corporations (ORIC).

#### **How URBAN+ Applies:**

Installing drinking water stations supports facility upgrades by enhancing water access, promoting responsible resources, and ensuring inclusivity. These stations contribute to the well-being of multicultural communities, fostering social connections in upgraded, accessible spaces while aligning with the Territory's social and cultural goals.

- Must contribute at least 10% cash toward project costs.
- Projects must address one of the identified funding streams, such as infrastructure, youth engagement, or community capacity building.
- The project must align with the Fund's objectives and demonstrate broad community support.

#### **How URBAN+ Applies:**

Urban+ drinking water stations support the Fund's goals by promoting healthy lifestyles, reducing plastic waste, and enhancing long-term ecological health. These stations improve learning environment, fostering focus and well-being while meeting capital expenditure criteria for accessible, sustainable infrastructure.
